TOWNSHIP OF OXFORD WORKSHOP MEETING OCTOBER 18, 2005

The regularly scheduled workshop meeting of the Mayor and Committee of the Township of Oxford was held on October 18, 2005 in the Township Municipal Building, 11 Green Street, Oxford, New Jersey.

In attendance were Alex Lazorisak and Phil Rosenberg.

Angelo Accetturo arrived at 8:00 PM.

Earl Babb of General Code submitted to the Committee a Code Revitalization Proposal for Oxford Township. The performance schedule is as follows:

- Recodification project should take between 10 and 11 months.
- Initial telephone conference within 30 days of authorization to proceed with project
- Submission of the Editorial Analysis within 150 days of authorization to proceed with project
- Submission by the Municipality of all desired changes to the Analysis within 90 days of submission of the Analysis.
- Delivery of Code within 60 days of approval to proceed with the publication of the Code

The fee schedule for the Recodification project is \$14,250.00 that includes ten Code Books and \$530.00 for the E-Code option.

On motion by Mr. Rosenberg, seconded by Mr. Accetturo and passed unanimously on roll call vote, the Code Revitalization Proposal was approved.

Charles Lilly, Officer in Charge of the Oxford Police Department requested that he be allowed to wear a white shirt instead of blue as part of his uniform requirement. The Committee approved his request.

Second reading, public hearing of Ordinance 2005-12 will be held on November 9, 2005 on or about 7:30 PM in the Township Municipal Building, 11 Green Street, Oxford, New Jersey.

On motion by Mr. Lazorisak, seconded by Mr. Rosenberg and passed unanimously on roll call vote, the Committee went into Executive Session at 9:00 PM.
